

Approaches to Contemporary American Literature

Series Editors: Aliko Varvogli (University of Dundee, UK); Chris Gair (University of Birmingham, UK)

The editors invite proposals for e-books to be included in a new series of approaches to American literature since 1970. We seek typescripts and proposals for books in any of the following (or similar) areas:

- Genre or theme-based studies of contemporary American writing (e.g. immigration and/or emigration narratives, new journalism, neo-slave narratives, travel writing, the short story, crime fiction, science fiction and fantasy writing)
- Theoretical studies of contemporary American literature (e.g. approaches based on gender studies, circum-Atlanticism, environmentalism, postmodernism, race, ethnicity, class)
- Critical studies of significant novelists, poets, dramatists, and other artists in relation to contemporary American culture

The Concept

Each series of Humanities-Ebooks monographs will make a contribution to scholarship in a particular field of research, as defined by the General Editor(s), and will be edited to the highest standards. It will be the aim of the publisher and of the editors jointly to ensure that the monographs achieve a standing equivalent to the products of conventional publishing houses, while offering considerable advantages in terms of affordability, availability, searchability, portability, protection of rights, and protection of intellectual property.

Technology

Humanities-Ebooks publishes only in electronic form. PDF versions purchased by individuals are downloaded to the purchaser's computer, licensed to one computer, and are encrypted to protect authors' intellectual property. HTML

versions purchased or subscribed to by libraries are password protected. Payment is through Paypal, providing security for purchasers and reducing overheads for authors.

Dividends

With *Humanities-Ebooks*, authors earn a variable dividend rather than a fixed royalty. The dividend is adjusted annually so as to distribute 100% of the net profit on each title. Eventually, something like 70% of net receipts should go to authors and editors, divided between them in the ratio of 4 to 1. That is, series authors will earn 80% of the net profit on sales of their title (after deduction of the publisher's fixed and monthly costs). Income from 100 sales of an Ebook title should comfortably exceed the average total income from a conventionally published monograph.

Responsibilities

The General Editor will give the series its initial rationale and will contribute a brief preface to each title; will operate a peer review process, and negotiate changes where necessary; will ensure that the author has secured any necessary permissions and paid any copyright fees required; and will provide the publisher with proof-read electronic copy prepared to an agreed template.

Authors will undertake to prepare their work within that template and within an agreed timescale, and to help to promote the work through newsgroups and other means. The Publisher will make the Ebook itself—adding the cover; creating hyperlinks and bookmarks; inserting or adjusting illustrations; setting the page transitions and opening parameters; providing publication data, ISBN, encryption and so forth—and will promote the series and distribute review copies.

Proposals

Proposals, containing a rationale, a table of contents, a proposed delivery date, and where possible a sample chapter, should be sent by email attachment to the editors a.varvogli@dundee.ac.uk and C.H.GAIR@bham.ac.uk. Proposals should indicate the likely structure and length of the eventual work, bearing in mind that electronic books need not conform to conventions established by the economics of print. An ebook containing 3 or 4 germinal essays, and totalling 45,000 words would be as viable as one of 10 chapters and 75,000 words.
